The terms and conditions are as follows:

- a.
1. He will be considered as 'on duty' during the entire period of deputation and travelling.
 2. He will be entitled usual salary and other benefits in Taka during deputation.
 3. After deputation period, as per bond, he will be bound to serve this institute for at least 07 (Seven) years from the date of joining.
 4. All expenditure will be borne by Yunnan Academy of Agricultural Sciences (YAAS).
 5. He will have to report to Bangladesh Embassy in China within seven days of his entrance in China.
 6. He must not overstay abroad beyond the deputation period.
 7. He must submit his academic progress report in every six month as per prescribed/BARI proforma.
 8. He must inform the institute of his full address of correspondence (Phone & E-mail number, Name and Address of Major Professor etc.) immediately after reaching China.
 9. After return, in the prescribed form of Ministry of Public Administration, he must submit three copies of report on higher training along with the joining letter to the Director General through proper channel.
 10. The Officer-in-Charge will take over all official goods from him before release and inform Director (T&C) Wing, BARI, Gazipur.
 11. He must abide by other government rules in this connection.


