5. He will have to report to Bangladesh Embassy in China within seven days of his entrance in China.
6. He must not overstay abroad beyond the deputation period.
7. He will submit his academic progress report in every six month as per BARI proforma.
8. He must inform the institute of his full address of correspondence with Phone & E-mail number and Name and Address of Major Professor with Phone & E-mail etc. just after reaching.
9. After return, he must submit three copies of report in the prescribed form of Ministry of Public Administration on higher study along with the joining letter with dissertation copy to the Director General through proper channel.
10. The Officer-in-Charge will take over all official goods from him before release and inform Director (T&C) Wing, BARI, Gazipur.
11. He must abide by other government rules in this connection.
